## Strengthening small-scale farmers

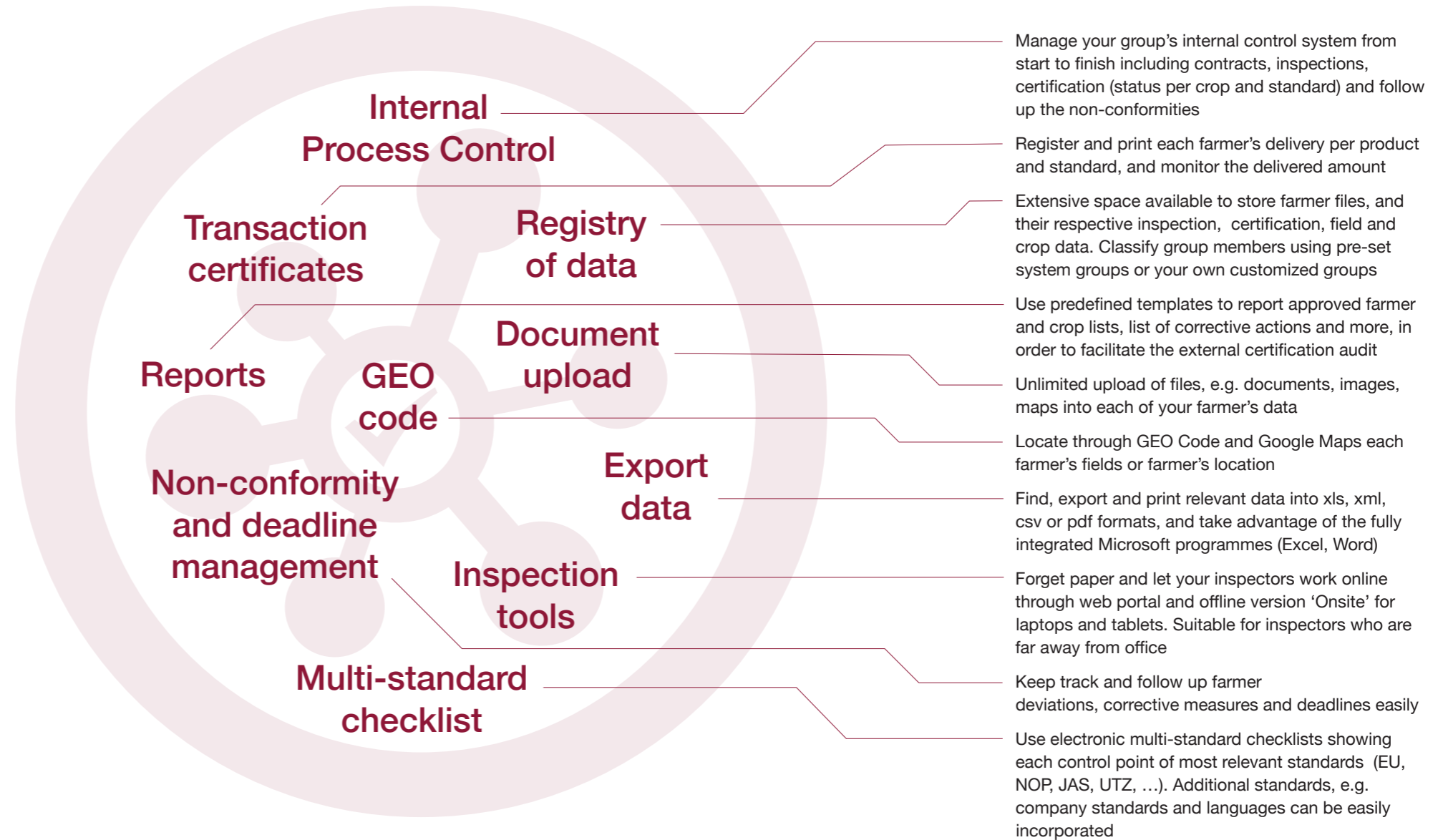
*Group Integrity* is an innovated software with a focus on cost efficiency that helps to improve growers' situation by reducing the burden of third party certification system.

The group certification schemes are accepted and applied globally, however, the implementation of a group's ICS remains a challenge and a demanding task for the groups that *Group Integrity* will address.
